NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 323 East Louetta Road, Spring, Harris County, Texas 77373, said address being a meeting place of the District.

The meeting will be held on Thursday, August 16, 2018, at 6:30 p.m.

The Board shall consider and discuss the following matters and take any action necessary and appropriate with respect to such matters:

1. Minutes of the July 19, 2018, Board of Directors meeting;
2. Receive the Financial Advisor's recommendation concerning the District's proposed 2018 tax rate, determine intended tax rate, and authorize:
 - a. the required notice that the Board will consider adoption of a tax rate; and
 - b. the means of providing such notice;
3. Comments from the public;
4. District security issues;
5. Review of EVO Report prepared by Municipal Financial Services;
6. Tax Assessor-Collector's Report, including, authorizing the payment of invoices presented and approve transfer of accounts to uncollectible roll;
7. Report and legal action taken by the District's delinquent tax collections attorney, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, filing of proofs of claims, and termination of service to delinquent taxpayers;
8. Bookkeeper's Report, including financial and investment reports, and authorizing the payment of invoices presented;
9. Discussion regarding landscaping within the District, including erosion mitigation and rehabilitation plans for the north and south lakes;
10. Detention and Drainage Facilities Report;
11. Engineer's Report, including:
 - a. Authorizing the design and/or advertisement for bids for the construction of facilities within the District, and approving of related storm water plans, including:
 - i. Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of District, and the execution of any documentation in connection therewith;

- b. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, approval of any related storm water permits and acceptance of TEC Form 1295;
 - c. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders, including:
 - i. Status of construction of lift station and force main to serve Northland Shopping Center; and
 - ii. Status of construction of lift station and force main to serve Bayer Park;
 - d. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes, and the taking of any action in connection therewith;
 - e. Status of Storm Water Quality Permits, and the taking of any action in connection therewith;
 - f. Status of submittal of application to North Harris County Regional Water Authority for District's participation in reimbursement program for use of reclaimed water;
 - g. Utility capacity availability;
 - h. Status of flushing of force main;
12. Discussion regarding utility capacity requests, including but not limited to:
- a. 3.67 acre tract at southeast corner of Spring Cypress and Lexington Boulevard (Car lots/Warehouse Building);
 - b. 19.810 acre tract (f/k/a Home of Hope Tract) (Lone Star College Transportation/Technology Center);
 - c. 20 acre tract (Choice Tee Property) (Mixed Use);
 - i. Status of annexation feasibility study;
13. Operation and Maintenance Report, including:
- a. Monthly Report;
 - b. Appeals of District charges;
 - c. Status of compliance with District's waste discharge permit;
 - d. Status of communications regarding Notice of Violation;
 - e. Status of communications regarding replacement of bar screen components;
 - f. Authorizing the repair and maintenance of District facilities, and the taking of any action in connection therewith, including additional improvements to wastewater treatment plant and manhole repairs;
 - g. Status of meter replacement program;
 - h. Status of flushing of District water lines;
 - i. Status of aged receivables; and
 - j. Refer accounts for collection;

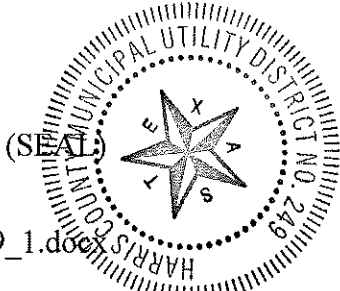
17. Reconvene in Open Session and authorize any action(s) necessary in connection with matters addressed in closed session; and
