The Board shall consider and discuss the following matters and take any action necessary and appropriate with respect to such matters:


1. Minutes of the September 20, 2018, Board of Directors meeting;
2. Comments from the public;
3. Conduct a public hearing regarding the adoption of the District's 2018 tax rate;
4. Levy of the District's 2018 debt service and maintenance taxes, and the adoption of an Order in connection therewith;
5. Approval and execution of an Amendment to the District's Amended and Restated District Information Form;
6. District security issues;
7. Tax Assessor-Collector's Report, including, authorizing the payment of invoices presented and approve transfer of accounts to uncollectible roll;
8. Report and legal action taken by the District's delinquent tax collections attorney, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, filing of proofs of claims, and termination of service to delinquent taxpayers;
9. Bookkeeper's Report, including financial and investment reports, and authorizing the payment of invoices presented;
10. Consider the Amended and Restated Agreement for Bookkeeping Services between the District and Municipal Accounts & Consulting, L.P. and acceptance of TEC Form 1295;
11. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;

    - i. Status of construction of lift station and force main to serve Northland Shopping Center; and
    - ii. Status of construction of lift station and force main to serve Bayer Park;
  - d. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes, and the taking of any action in connection therewith;
  - e. Status of Storm Water Quality Permits, and the taking of any action in connection therewith;

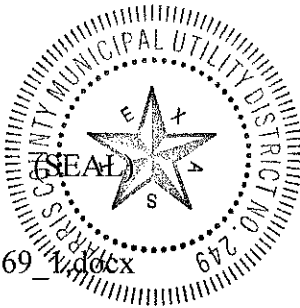
