The Board shall consider and discuss the following matters and take any action necessary and appropriate with respect to such matters:

- 1. Public comments;
- 2. Acceptance of Qualification Statements, Bonds, Oaths of Office, Affidavits of Current Director for elected Directors;
- 3. Elections Not to Disclose Certain Information;
- 4. Election of officers of Board of Directors;
- 5. Approval of District Registration Form relative to election of Directors;
- 6. Authorize preparation and maintenance of a local government officers list in connection with conflict of interest disclosure requirements;
- 7. Minutes of the April 16, 2020, Board of Directors meeting;
